PRIVACY AND DATA PROTECTION POLICY

This policy sets out how The Vintage Austin Register Ltd lawfully collects, handles, processes, and respects its members' personal data and the entitlements of each member in relation to the personal data of that member.

At the VAR we take the privacy of our members' data seriously and will only use the personal information as supplied by members for Club administration purposes and for communicating with members about their membership. Only the Registrar, the Treasurer, and the Spares Secretary will be able to access these details. The only personal data held by VAR is that provided by an individual on joining or renewing their membership of VAR. Members' personal data is only included in the annual list of Members & Cars with members' specific agreement.

We will never sell or share members' data (except with our printers who print and distribute our newsletter, magazine, and list of members & cars) without members' permission.

The computerised VAR system held and operated by the Registrar is password protected for entry and in addition, is separately password protected to gain access to Members' records. Data sent to our printers is encrypted and password protected.

The legal basis for collecting the data is for the purposes of the Club's legitimate interests to assist in the administration of the Club and its membership, and communication with members. Furthermore, under the Club's Memorandum and Articles of Association, the Club was established "... To keep a register of all existing Austin vehicles manufactured until 1939, belonging to current and past Members, and maintain records on all other Austins of Historical interest". The data will be kept for archiving for historical research purposes.

We keep Members' data after they resign or their membership lapses. However, we will delete any former Members' contact details entirely on request.

Members can check the data we hold and ask for it to be removed, limited, or corrected at any time.

Any questions or requests in relation to this policy, or any suspected or actual breach of this Policy, should be addressed to the VAR Company Secretary who will be given access to the member's details but only to the extent necessary properly to deal with the issue in question.
